IS THERE A HOMEOWNER'S ASSOCIATION AT THE FAIRWAYS AT RAINDANCE NATIONAL?

Yes. All The Fairways at Raindance National homeowners will be members of the homeowner's association (HOA). General HOA dues are currently estimated to be \$300.00 per year. There is also a non-potable water fee of \$257 annually with a service fee of \$3.95 for every 1000 gallons used

The Fairways at RainDance National HOA dues include landscape maintenance of common areas, snow removal, and trash. All RainDance National homeowners will be individually responsible for all services to their residence, including, but not limited landscaping, water/sewer, gas, electric, cable/satellite TV, Internet, telephone, etc.

DOES THE FAIRWAYS AT RAINDANCE NATIONAL HAVE A PREFERRED LENDER?

Yes. All interested homebuyers are required to obtain pre-qualification approval through preferred lender(s) – Tara Doak with Group Mortgage, Justin Ownbey with Guaranteed Rate or Brenda Stifter with Prime Lending. Buyers who utilize Acadia's preferred lender(s) for their loan will receive a credit in the amount of \$3,500 at closing that can be used toward closing costs.

HOW MUCH IS THE INITIAL DEPOSIT TO PURCHASE A HOME?

A deposit equal to \$100,000, made payable to Heritage Title, is required at the time of contract. Initial reservation requires pre-qualification only; wire, personal checks or cashier's checks are acceptable forms of deposit.

ARE THERE ANY ADDITIONAL DEPOSITS?

Yes. Most optional upgrades require an additional deposit. Optional electrical upgrades require a 25% deposit. Flooring, cabinets, countertops, and other optional design center upgrades require a 25% deposit at the time of selections.

WHAT IS THE TAX RATE?

RainDance National's tax rate is approximately .93% of the assessed value, including the metro district.

IS RAINDANCE NATIONAL LOCATED IN A METRO DISTRICT?

Yes, all homes in The Fairways at RainDance National are located in a Metro District with a Mill Levy of 41.39.

WHAT ARE THE DESIGNATED NEIGHBORHOOD SCHOOLS?
